The GGRF is a groundbreaking program that aims to reduce greenhouse gas emissions in various sectors, such as transportation, energy, and buildings. Sustainable Transportation Infrastructure: The transportation sector is a major contributor to greenhouse gas emissions, making it a prime target for GGRF-funded projects. SELF will be launching new loan products for EV charging stations and potentially e-bikes and EVs. Stay tuned.

The GGRF supports projects that prioritize environmentally friendly building materials, energy-efficient design, and low-carbon construction methods, presenting lucrative opportunities for contractors in the construction industry.
